Through a partnership with the City of Los Angeles and the County of Los Angeles, all first graders at your child's school are eligible to have a Children's Savings Account **at no cost to you or your family.**

**You do not need to do anything if you would like your first grader to participate in this program.** Your child's savings account will be automatically set up. L.A. Unified will share the following information on your behalf with the City of Los Angeles Community Investment for Families Department (CIFD):\*

- Your name and your first grader's first and last name
- Your first grader's date of birth
- Your address
- Your child's current and most recent previous school(s)

If you would **NOT** like your first grader to participate in this program, please complete the opt-out form and email the form to [instruction@lausd.net](mailto:instruction@lausd.net) or return a copy of this form to your child's school **no later than Friday, October 25, 2024.** A copy of this form is also available at your child's school in the front office.
